#### Looking down the street...

- Union Rescue Mission (Los Angeles, Calif.) was one of the winners of the "12 Days of Giving" Facebook campaign held by the Walmart Foundation. Each year, Walmart and the Walmart Foundation provide funding to nonprofit organizations during the holiday season. In 2011, Walmart gave \$1.5 million to 145 local organizations in all 50 states, Washington, D.C., and Puerto Rico to help fight hunger and provide basic-need items.
- Orange County Rescue Mission (Tustin, Calif.) recently handed out flashlights and
  whistles to help homeless people protect themselves after several homeless men were
  stabbed to death in north Orange County. Jim Palmer, president of the mission, was quoted
  in local and national media, urging homeless people to sleep in groups or to find an
  emergency shelter. A 23-year-old male suspect was arrested Friday, although a motive for
  the killings remains a mystery.
- A ruling by a federal judge allows homeless sex offenders to legally stay in overnight shelters in Grand Rapids, Michigan, even if those shelters are too close to schools. The ruling came as the result of a lawsuit filed by five homeless or previously homeless sex offenders, AGRM member Mel Trotter Ministries, and another local homeless shelter. Mel Trotter and the other shelter are too close to schools, as is AGRM member Guiding Light Mission, although that shelter was not part of the lawsuit. "We're in the mission of saving lives," said Mel Trotter CEO Chico Daniels. "We're not interested in sending anyone out to die in the street and so, with great angst and regret, we did in the past have to turn people away."



#### Homeless teenager named semifinalist in science competition

Samantha Garvey and her family had been living in a shelter in Brentwood, New York, for several days when they got word the 17-year-old aspiring marine biologist had made it to the semifinals of the prestigious national Intel science competition. According to a *Huffington Post* report, news of the teenager's homelessness prompted donations to pour in from across the country, and the county was able to find her family rent-subsidized housing. Garvey is one of 300 semifinalists nationwide named this week in competition; finalists will be announced at the end of the month. Garvey spent more than two years researching the effects of the Asian short crab on the mussel population in a salt marsh on Long Island, east of New York City. The Brentwood High School senior was evicted along with her family from their home on New Year's Eve. Her mother, a nurse's assistant, was out

of work for eight months following a car accident and her father couldn't keep up with the bills alone on his salary as a cab driver.

#### Food bank gets creative with donations

A food bank in the Denver metro area that has helped hundreds of families for nearly 20 years is looking for help of its own. According to a <u>9News report</u>, the Loving Hands Organization in Aurora, Colorado, is still accepting food donations. But because of continuing economic conditions, it is also now asking for donations of something that most people throw away: coupons. The reasoning is simple, according to the food bank's founder. "The more coupons we get, the more food we can buy, and the more families we can help."

#### Supreme Court acknowledges exception to anti-discrimination laws

In a groundbreaking case, the Supreme Court on Wednesday held for the first time that religious employees of a church cannot sue for employment discrimination. According to a *Bloomberg Businessweek* report, the ruling marked first time the high court has acknowledged the existence of a "ministerial exception" to anti-discrimination laws. This doctrine says the First Amendment's guarantee of freedom of religion shields churches and their operations from the reach of such protective laws when the issue involves employees of these institutions. The case came before the court because the federal Equal Employment Opportunity Commission (EEOC) sued the Hosanna-Tabor Evangelical Lutheran Church and School of Redford, Michigan, on behalf of an employee who complained of discrimination under the Americans with Disabilities Act. Writing the court's opinion, Chief Justice John Roberts said that allowing anti-discrimination lawsuits against religious organizations could end up forcing churches to take religious leaders they no longer want. "Such action interferes with the internal governance of the church, depriving the church of control over the selection of those who will personify its beliefs," Roberts said. "By imposing an unwanted minister, the state infringes the Free Exercise Clause, which protects a religious group's right to shape its own faith and mission through its appointments."



#### Eating processed meat raises risk of deadly form of cancer

Eating just two slices of bacon or one sausage a day can increase a person's risk of a deadly form of cancer by almost a fifth. According to a <a href="Fox News report">Fox News report</a>, eating 1.8 ounces of processed meat a day can increase the risk of pancreatic cancer by 19 percent, and consuming 3.5 ounces increases the risk to 38 percent, and to 57 percent for those eating 5.3 ounces a day. While the study notes that the overall risk of pancreatic cancer is relatively low, the disease is deadly because it is frequently not diagnosed until it's at an advance stage; 80 percent of those diagnosed with the cancer die in less than a year. The new findings are based on data from 11 studies, including more than 6,600 cases of pancreatic cancer. "Findings from this meta-analysis indicate that processed meat consumption is positively associated with pancreatic cancer risk," the study's authors said.

#### Search engine trends allow doctors to respond to flu outbreaks

Google, the search-engine giant, might be able to help doctors anticipate when they'll get a surge in the number of patients they see with flu symptoms. According to a <u>Time magazine report</u>, this finding comes from a team of doctors, based in Baltimore, who relied on Google Flu Trends, a

service that tracks the number of flu-related Internet searches by individuals. The study looked at how data from Google Flu Trends stacked up against conventional systems to track the spread of flu. In addition to being quite accurate, the service also had a major advantage over traditional surveillance: The Google data is updated every day and available to doctors almost instantly. Official surveillance data, in contrast, can take weeks to be compiled and distributed by the federal Centers for Disease Control and Prevention (CDC), meaning doctors may not hear about rapidly emerging flu outbreaks until they're well underway. To conduct their study, the researchers took local Baltimore data from the Google service, and compared it to data from their own patients: 21 months' worth of statistics on emergency-room crowding and on lab tests for influenza. The finding suggests that an up-to-the-minute surveillance system might be possible, allowing hospitals to call in extra staff or to open up available rooms to allow additional patients.

#### Nicotine replacement products don't help smokers quit for good

For smokers who want to quit permanently, a new study finds that nicotine replacement therapies (NRTs) such as the nicotine patch or gum might not be as effective as some people trying to quit would hope. According to a <u>CBS News report</u>, the study followed 787 adult smokers in Massachusetts who had recently quit smoking. Participants were asked if they had used a nicotine replacement therapy to help them quit and for how long. Participants were also asked if they received help from a quit-smoking program, doctor, counselor, or other professional. "This study shows that using NRT is no more effective in helping people stop smoking cigarettes in the long-term than trying to quit on one's own," the study noted. Earlier studies have shown media campaigns, no smoking policies, and tobacco price increases are more effective smoking cessation tactics for the general population. Statistics from the Centers for Disease Control and Prevention show that adult smoking rate decline and quitting rates have stalled in the past five years.



#### **Homeless Shelter Makeovers**

<u>Deserving Decor</u>, a nonprofit in Bucks County, Pennsylvania, has an interesting idea you might adopt or adapt. The organization has provided more than 60 transitional homeless shelter apartment makeovers throughout Bucks County in the past two years and supplied numerous newly housed families with furnishings and household goods. The nonprofit repairs and replaces furniture, electronics, appliances, dishes, and décor; cleans apartments as part of the makeover process; and decorates the housing with artwork, window treatments, area rugs, and other decorative items. The agency also supplies furnishings, housewares, and home decor to families leaving shelters and acquiring their own residences.
